LEGAL NOTICE NO. 85

THE FISHERIES ACT, NO. 7 OF 2010

MARINE CONSERVATION UNIT (AMENDMENT) REGULATIONS, 2025
[Made under section 19(3)]

IN EXERCISE of the powers conferred upon me under section 19(3) of the Fisheries Act, No.7 of 2010, **I, SHAABAN ALI OTHMAN**, Minister for Blue Economy and Fisheries, do hereby amend the Marine Conservation Unit Regulations, 2014 as follows:

PART ONE
PRELIMINARY PROVISIONS

Short title and commencement.

1. These Regulations may be cited as the Marine Conservation Unit (Amendment) Regulations, 2024 and shall come into operation after being signed by the Minister.

Construction.

2. These Regulations shall be read as one with the Marine Conservation Unit Regulations, 2025 hereinafter referred to as the "Principal Regulations".

PART TWO
AMENDMENT PROVISIONS

Repeal and replacement of Schedule B

3. The Principal Regulations is amended by repealing Schedule B and replacing it with a new Schedule B as follows:
